**Parent’s Covenant**

We are aware of the element of competition, and release all rights and claims for damages we have against any party for injuries that may occur. We agree with the purpose of the league, and understand that all players and parents should keep in mind that this league is unique in that good sportsmanship and total participation are just as important as winning the game. We are also aware that all players will play in each game, and that if there is a violation of team or league rules, the game may be forfeited. We are aware that players must be members or attend the church on a regular basis and be active in Sunday School, Worship, Children’s Ministries and/or UMYF on a regular basis. We are aware that each team is required to carry accident insurance on all team players. *As the parent/guardian, we will provide an example to our child during games by supporting the team and by withholding negative comments that contradict the message of Christian sportsmanship.*

**Player Covenant**

I understand that playing basketball in the Cannon’s Camp Ground UMC basketball program requires that I faithfully follow and obey all rules. I will be responsible for equipment and keep it in good condition. I will try to stay in good physical condition, and will not let my studies and grades in school suffer. I will attend all practices and arrive on time if possible. If I am not selected as a regular player, I will not grumble – I will try even harder. I understand that in order to participate in these programs, I must be active in Sunday School, Worship Services, Children’s Ministries, and/or UMYF on a year-round basis. If I fail to follow the rules of the program and league, then I may be dismissed from the team. I am aware that I must be a good sport and that good sportsmanship will be stressed in this league.

As a representative of Cannon’s Camp Ground United Methodist Church and its basketball program, I understand that I am to respect my coach(s), fellow team members, referees, scorekeepers, and opposing teams at all times, to show Christian sportsmanship, and to represent the church and Jesus Christ in a wholesome manner. I also understand that if I cause problems for my coach(s) and/or team through disruptive behavior and/or disrespect, I will receive one warning. If my disruptive behavior continues, I understand that my coach(s) will ask me to sit on the sidelines for the remainder of the practice. If my behavior continues to be disruptive and/or disrespectful, a conference will be held with me and my parents. Should this conference not remedy the disruptive behavior, then I understand I will be released from the basketball team and program.

I also understand that if I make intentional physical contact with a member of my team or a member of the opposing team, I will be dismissed from the team. **PLEASE NOTE: Fighting or the intention of fighting will not be tolerated in this basketball program.**
